Please read the following information carefully. You must sign at the bottom indicating that you understand and agree to all of the following.

READY is a place for all children to learn, have fun and feel good about themselves. We want to help students do better in school and learn to cooperate with others. You are an important partner in our program's success.

## **Basic Information and Rules**

- Enrollment: Enrollment is limited. After submitting your completed registration, you will be informed if your child is enrolled in the program and his/her start date. Students in Foster Care and/or are homeless, are provided priority enrollment.
- 2. Attendance: It is expected that each child will attend the program daily. Students with excessive absences from the program may be dismissed. Any child who has 5 unexcused absences from READY will be dropped from the program. It is also expected that students will stay for the entire duration of the program each day. Students should report to the program immediately after school to check in with program staff. Students seen hanging around the playground or any area within or near the campuses will be considered truant. Three (3) truancies will be a reason for dismissal from the program.
- 3. Student Pick-up: Safety is a top priority; therefore no child will be allowed to walk home. You must pick your child up at 6:00 p.m. If your child is not signed out by 6:10 p.m., the School Administration will make a decision on where to take the student. After three times of your child not being picked up on time, your child may be dropped from the program. Persons picking up the child must provide photo identification when asked to do so by a staff member to verify identity with the Emergency Card.
- 4. Excused Early Pick up: We understand students may participate in outside activities that may require the need for leaving early from the program. If a student is picked up early from the program for reasons that are not considered excused, the student will be dropped after the 5th unexcused early pick up. Excused early pick up include:

- Sports Recreational Activities Religious Reasons Family Business Doctor/Dentist Appointment Tutoring Transportation Weather Illness/Injury/Medical Court School Function School Emergency
- 5. <u>Discipline:</u> Participation in the program is a privilege. Your child will be expected to follow the HESD's Student Conduct Code at all times during the READY Program. Disruptive or disrespectful behavior toward other students and/or program staff is reason for dismissal. READY reserves the right to cite, suspend or dismiss any READY student at any time for inappropriate behavior while attending the program. We encourage parents/guardians to discuss concerns with the school administrator or Site Lead. Information regarding your child will be kept strictly confidential.
- 6. <u>Responsibilities:</u> It is important that we are able to contact parents/guardians when needed. Therefore, it is the parent/guardian's responsibility to notify the READY staff of any change of address or telephone numbers.
- It is the responsibility of the parent to notify the READY Program of any change of address or school site at anytime during the school year. Program participation is based on enrollment and there may or may not be space available at a new school site, which may result in your child being placed on a waiting list.
- It is the student's responsibility to bring their homework to the program. The parent/guardian should check homework when their child gets home every single day.
