Highlights

- Unrestricted general fund ending fund balance of \$9,199k
 - \$ 153k stores inventory/revolving cash
 - \$9,046k reserve for economic uncertainties (14.9% vs 17.0% recommended)
- Restricted general fund ending fund balance of \$819k
 - (\$ 358k) Energy Jobs Act
 - \$ 161k Educator Effectiveness
 - \$ 456k Restricted Lottery
 - \$ 368k Special Education – Mental Health
 - \$ 133k Routine Restricted Maintenance
- Charter fund ending balance of \$361k.
- Cafeteria Fund ending balance of \$1,346k.
- General Fund ADA grew by 30 and Charter Fund ADA grew by 33.
- Capital Facilities Fund grew by \$235k with 114 residential building permits issued.

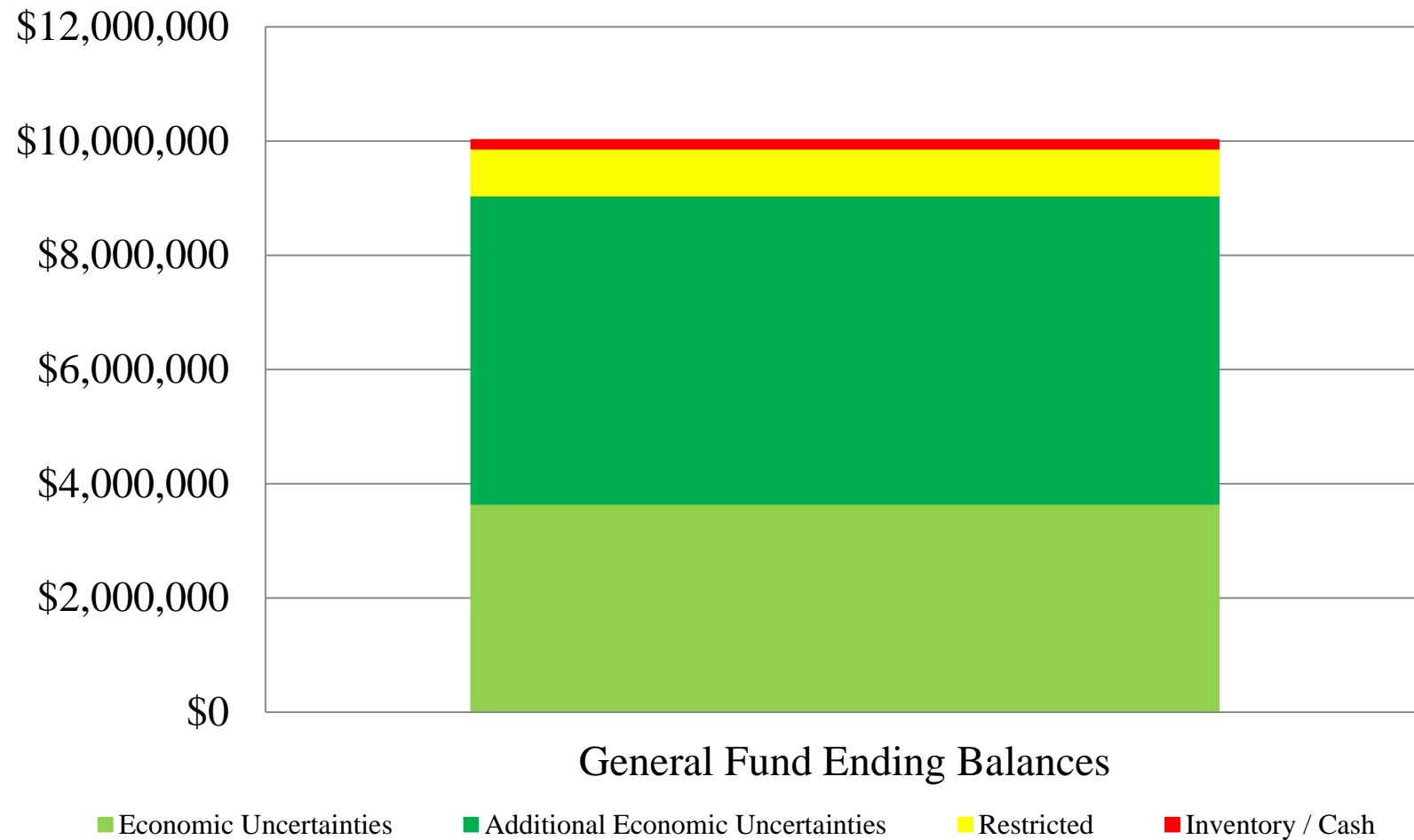
